Consent to Electronic Notice and Disclosure Form

The Steamfitters' Industry Fund Office encourages all members to go green! If you have a work or home e-mail address, you can opt to receive your employee benefits information electronically.

Here's how it works:

- When you consent to electronic delivery of employee benefits information, you will receive e-mail notifications when new notices and disclosures have been posted to the Steamfitters' Internet site at www.steamfitters.com.
- To view your Employee Benefit Notices and Disclosures, you can go directly to the Steamfitters' website, or simply click the links provided in your notification e-mails.

Prior to consenting to the electronic delivery of your Employee Benefit Notices and Disclosures, you should understand:

Signature required: To receive Employee Benefit Notices and Disclosures electronically, you must sign this form.

Access: If you do not have regular access to a computer connected to the Internet you should not consent.

SPD: Each benefit plan has a Summary Plan Description (SPD), which describes the major components of your plan. Your plan's SPD will be available on the Steamfitters' website.

Summary of Material Modification (SMMs): SMMs summarize significant changes made to your benefit plan. Your plan's SMM will be available on the Steamfitters' website. The SPD and SMM are important documents that you should review periodically.

Withdrawal of Consent: You have the right to withdraw your consent to Electronic Notices and Disclosures at any time at no charge. To withdraw your consent, you <u>must</u> notify the Fund Office in writing or send an e-mail to <u>FundOffice@steamny.com</u>.

Paper Version of a Document: If you consent to electronic distribution, you may still request a paper version of any document free of charge. All benefit notices, including SPDs and plan amendments, are available on the Internet as PDF files.

Updating Your Email Address: To update your email address for receipt of Electronic Notices and Disclosures, you must notify the Fund Office in writing or via email at <u>FundOffice@steamny.com</u>.

Hardware and Software Requirements for Accessing and Retaining Documents: Electronic notifications can be received at any valid e-mail address on file with the Fund Office.

Consent to Electronic Notice and Disclosure

I consent to the electronic delivery of all **Employee Benefit Notices and Disclosures**, including Summary Plan Descriptions and SMMs.
