### Pre-Retirement Death Benefit Designation of Beneficiary

If you are married and designate anyone other than your spouse as beneficiary of the Pre-Retirement Death Benefit, the Waiver on the reverse side must be completed by you and your spouse. Your beneficiary can be changed at any time subject to the need for spousal consent. If you have any questions regarding the completion of this form, please call the Fund Office.

**Instructions:**

- ◆ **IF YOU ARE MARRIED** and you name your spouse as beneficiary, only complete the area below.
- ◆ **IF YOU ARE MARRIED** and you name a person *other than your spouse* as beneficiary in the space below, you must complete the "Employee's Statement" on the reverse side. Your spouse must also complete the "Spouse's Statement." Your spouse must agree to the beneficiary you name. If you and your spouse do not agree on a beneficiary, the Beneficiary Designation is invalid and in the event of your death the Fund will pay your pre-retirement survivor benefits to your spouse as a 100% Surviving Spouse benefit.
- ◆ **IF YOU ARE NOT MARRIED**, you may name anyone as your beneficiary.
- ◆ **Print in ink.** Be sure all signatures and dates are completed in all sections.
