# HEALTH REIMBURSEMENT ACCOUNT COMMENCED JULY 1ST NEW FINANCIAL ASSISTANCE AND HOUSING BENEFIT IN FULL SWING

The first reimbursement checks in the newest addition to your employee benefit programs, the Health Reimbursement Account (HRA), rolled off the presses right after the Independence Day holiday. The HRA can reimburse you for all post January 1, 2005 medical care and associated expenses not covered by insurance on a tax-free basis. The Account will be funded by \$1.00 per journeyman hour (pro-rated for apprentices). If your benefit application is larger than your HRA balance funds from your Security Benefit Fund account can be transferred in to take advantage of the tax-free reimbursement.

HRA Benefit applications, pink in color, are available in the Fund Office, Union Office, through the Fund Office website [www.steamfitters.com] or by mail by calling the Help Desk at 212.465.8888, Ext. 244. Since the applications are new please read them carefully and follow the instructions closely. The HRA will be an excellent addition to your benefit programs.

July 1st also brought with it the two newest benefits under the Security Benefit Fund- - - the Financial Assistance Benefit and the Acquisition or Retention of a Residence or Rental Unit Benefit, commonly referred to as the "Housing" Benefit.

The Financial Assistance Benefit will reimburse you, subject to your account balance, for an unpaid home mortgage, co-op or condominium mortgage and/or maintenance fees, rent or property taxes for any month that you were unable to work and are receiving for the same month, Unemployment Benefits, Disability Benefits or Workers Compensation benefits. Only claims for periods on or after July 1, 2005 are eligible for this benefit.

The "Housing" Benefit can be used for certain costs associated with the purchase of a new residence, initial rental costs, or to prevent eviction or foreclosure. In all cases, this benefit is only allowed to be used for your primary residence, which must be located with a reasonable commuting distance from the Local 638 jurisdiction. In addition, since this benefit can not be used for post-retirement purposes, retired participants are excluded from this benefit at present.

Both the Financial Assistance and Housing Benefits have more detailed explanations which you must read and which were contained in the April 2005 Notice mailed to all participants and which can be found on the Fund Office website [see the bottom of the Forms section under Summary of Material Modifications]. Applications for both new benefits are available in the same manner as stated above for the HRA.

## MEDCO ISSUES NEW PRESCRIPTION DRUG ID CARDS FOR ONLY MEMBERS RESIDING IN CONNECTICUT AND CALIFORNIA

## NEW ID CARDS FOR ALL MEMBERS TO BE ISSUED LATER IN 2005

Earlier this year state legislatures in Connecticut and California passed privacy laws requiring the non-use of Social Security numbers on healthcare ID cards as of July 1, 2005. Therefore, all active or retired participants residing in those states recently received new ID cards with unique ID numbers. In addition, similar laws have the been passed in Arizona, Illinois, Michigan and Texas requiring non-SSN on ID cards as of January 1, 2006.

Therefore, in order to facilitate these various state laws, anticipating additional state mandates and to further protect your privacy Medco will be re-issuing ID cards which will utilize random ID numbers to all participants in the latter part of this year. If you recall Empire BlueCross BlueShield has already taken similar action as the Empire ID card you possess does not have your SSN on it.
