# EMPIRE BLUE CROSS ISSUES NOTICES REGARDING CANCER RELATED BENEFITS AND PROTECTING MEMBERS' PERSONAL INFORMATION

Empire wants to be sure that all members receive the best possible care when they get sick. The following cancer-related benefits are available to you and your covered family members:

- Members are entitled to get a second medical opinion. You are covered for a second opinion office visit and any associated diagnostic tests related to a cancer diagnosis or recurrence.
- Members can receive hospital care for an inpatient hospital stay following a lymph node dissection, lumpectomy or mastectomy for the treatment of breast cancer.
- Members can get reconstructive surgery for the following breast cancer-related treatments: reconstruction of the breast on which a mastectomy has been performed; symmetrical reconstruction of the other breast to produce a symmetrical appearance; prostheses and treatment for complications resulting from a mastectomy including lymphedema.

The manner in which medical services are provided are strictly between the member and his or her physician. However, you must pre-certify your treatment or any inpatient stay with the Medical Management Program at 800.553.9603.

Empire has established strict polices and procedures to comply with all federal and state privacy laws and regulations. New York State requires that information about these policies and procedures be periodically disseminated to its members. The following is a summary of the guidelines:

- Empire will not disclose a member's information except as permitted by the member or as permitted or required by law. Each member's personal information is considered confidential and is only used in accordance with Empire's Privacy Policies and Practices that restrict access to and disclosure of all confidential information.
- Access to personal information on the Empire website is protected through registration processes and passwords that identify and authenticate users. Empire meets strict, detailed federal standards for protecting electronic communications.
- A member's right to privacy extends to all forms of contact including telephone and written correspondence.
- Empire employees have limited access to member information based on their responsibilities. Access is provided only to those employees who need to know information about a member to provide the products or services that a member needs.
- Empire maintains physical, electronic and procedural safeguards that comply with all legal requirements. Empire does not see mailing lists that contain member names, addresses and personal information.

These new ID cards no longer contain your Social Security Number in the interest of protecting your privacy. The new ID numbers are randomly selected by computer. If you have not received your new ID card please contact the Fund Office Help Desk at Ext. 244 for assistance.

In early March 2005 all covered Steamfitters' members will receive similar ID cards with the randomly selected ID number. Keep an eye out for them!
